## **RJC, Government Center Visitors Reminded Of Upcoming Traffic Impacts Due to Grand Prix**

Starting Monday, April 2, through Sunday, April 8, motorists coming to the Clark County Government Center, the Regional Justice Center and other county buildings downtown may encounter street closures and traffic delays in preparation of the Vegas Grand Prix over Easter weekend.

The three-day festival, which includes car races along a 2.44-mile circuit of downtown city of Las Vegas streets, officially begins **Friday, April 6**, but several street closures will go into effect in phases during the week to accommodate the traffic plan for the event. County offices will be open normal business hours, 8 a.m. to 5 p.m., Monday through Friday, April 2-6. The public, however, is advised that starting **Monday, April 2**, Bridger Avenue will be closed to traffic between Main Street and east of Third Street, limiting access to the Regional Justice Center, the Clark County Parking Garage and nearby facilities. On **Wednesday, April 4**, access to the Government Center will be limited through Sunday to Charleston Boulevard via Grand Central Parkway. As road closures go into effect during the week, motorists are advised to take extra time to reach downtown destinations. Las Vegas Boulevard and Charleston Boulevards will serve as main thoroughfares into the area. Key access routes to county facilities are summarized as follows:

- **Clark County Public Parking Garage, 300 S. Casino Center Drive**

- **Public Defender, Las Vegas Township Constable, Marriage Commissioner, Law Library, 309 S. Third St.**
  - Bridger Avenue will be closed to traffic between Main Street and Third Street. Access to the Regional Justice Center will be limited to Las Vegas Boulevard and Clark Avenue. First Street will be closed between Bridger and Ogden avenues. Third Street will be closed between Carson and Ogden avenues.
  - Access to the Clark County Parking Garage will be available via the entrances and exists on Casino Center Boulevard and First Street. The garage offers employee parking, and paid public parking on a first-come, first-serve basis. Paid parking for court-related business also is available at the county's lot located south of the Regional Justice Center on Bonneville Avenue between Third Street and Casino Center.

- Several road closures north of the Government Center also go into effect.

### • **Festival Attendees**

- General admission ticket holders are encouraged to park at Cashman Field Center, 850 N. Las Vegas Blvd., and other locations where transit service to event stops is available. ### • **Clark County Government Center Complex**

- Motorist access to the Government Center complex, 500 and 600 S. Grand Central Pkwy., will be limited to Charleston Boulevard via Grand Central Pkwy.
- **Friday, April 6** – Access to the Government Center parking lot will be granted to employees with identification badges, and the public for county-related business.
- **Saturday, April 7** – Limited public access to the Government Center parking lot will be granted to accommodate the Bunny Boogey Easter egg hunt in Clark County's outdoor Amphitheater from **noon to 4 p.m.**
- **Sunday, April 8** – Employee-only access to the Government Center's parking lot will be granted on **Sunday, April 8**. Employees must show county identification badges.

### • **Clark County Regional Justice Center & Clark County Parking Garage**

- **Friday, April 6** – Jurors reporting to the Regional Justice Center will park at the Fremont Street Parking Garage located on the corner of Las Vegas Boulevard and Carson Avenue. Jurors should enter the garage from Carson Avenue, upon presenting copies of court summonses to parking staff. The entrance on Fourth Street will be closed.
- Paid, public parking will be available at the Clark County Parking Garage, 300 S. Casino Center, on a first-come, first-serve basis **Saturday** and **Sunday**.
- Paid parking will be reserved on **Friday** for court-related business at the county's lot located south of the Regional Justice Center on Bonneville Avenue between Third Street and Casino Center. Court Education classes scheduled for Saturday, April 7, have been rescheduled.
- County employees scheduled to work Saturday or Sunday will be granted access to the garage if their names appear on a department authorization list. Employees must present employee identification badges. ###
